<u>Tree Work Specifications</u> <u>For</u> <u>Heath Hurst Communal Gardens</u>

T3: Sycamore

Works: Crown reduce by 20% to encourage a more balanced crown for the long term. <u>Reasons:</u> Western crown is unbalanced due to suppression over a number of years from the adjacent Poplar which has fallen/been removed.

T4: Sycamore

Works: The crown of the tree is unbalanced due to damage from the fallen Poplar. Crown reduce by 25% to give a more balanced crown. Reasons: The tree has significant decay at 0.5-2 2m. The decay is likely to extend higher than this




T5: Ash

T7: Ash

Works: Crown reduce by 30%. **Reasons:** The tree has significant decay from ground level to 3m (visually) although it is likely that the decay extends higher. The tree has some over-extended limbs to the north requiring management.

Works: Cut the entire tree to ground level. **Reasons:** This tree is being suppressed by T6 and it's form could cause problems in the long term. The removal of this tree would allow adjacent Ash sapling to flourish.
